Hon. Thomas McPhee (Ret.) brings to dispute resolution at JAMS more than 45 years of legal experiences JAMS neutral, judge, and trial lawyer. He served 22 years on the Thurston County Superior Court, retiring in 2013 with a statewide reputation as a jurist committed to hard work and intellectual curiosity in all matters related to law and justice. He was a trial lawyer in private practice for 20 years, trying cases in Federal Court and in nearly every county in western Washington.
